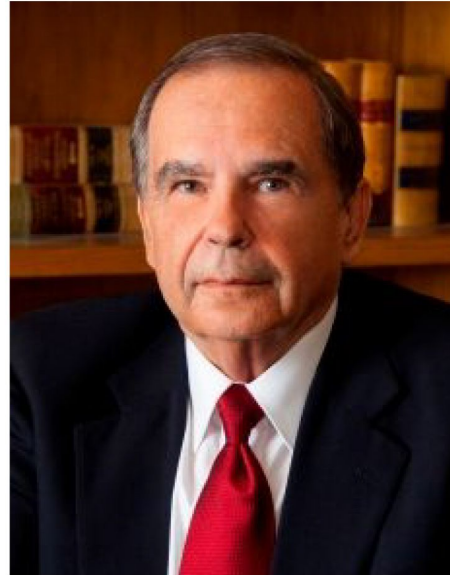

Superior Court*, 47 Cal.App.3d 334 (establishes tort of the essence); *Leach v. Drummond Medical Group*, 144 Cal.App.3d 362 (establishing a tort for refusing treatment to a class of patients in a medical monopoly); and *Bank of America v. S.C. Anderson*, 24 Cal.App.4th 529 (defining elements of the damages of lost profit for a contractor).

As a Bakersfield attorney, George has mediated and arbitrated large complex cases and simple automobile cases with the same diligence to getting the parties to agree to reach a resolution.
